

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.therarezebra.com, and Rara Enterprises LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Rara Enterprises LLC include www.therarezebra.com, The Rare Zebra, ChronicallyRara and www.chronicallyrara.com. The The Rare Zebra website is a e-commerce site. By using the The Rare Zebra website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The Rare Zebra may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase The Rare Zebra's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

The Rare Zebra may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Anything that will allow us to better understand our customer base

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

The Rare Zebra collects and uses your personal information to operate and deliver the services you have requested.

The Rare Zebra may also use your personally identifiable information to inform you of other

products or services available from The Rare Zebra and its affiliates.

Sharing Information with Third Parties

The Rare Zebra does not sell, rent or lease its customer lists to third parties.

The Rare Zebra may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to The Rare Zebra, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by The Rare Zebra. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the The Rare Zebra website.

Use of Cookies

The The Rare Zebra website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. - Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
